IT IS ALSO RECOMMENDED THE TRUCK/TRACTOR IS EQUIPPED WITH A SS PUMP IF DRIVER IS TO OFF-LOAD VIA TRUCK PUMP, TO MAINTAIN PRODUCT QUALITY.</p>
